- I. Review of Enrollment and Admission Data

- II. Updates:
 1. UFO
 - a. General updates
 - i. 160/90 is working on their discovery plan to work on their marketing. Have reached out to lots of folks involved in the project to get some feedback
 - b. Program coach transition plan
 - i. Pearson will send a letter from the program coach to the student explaining the transition
 - ii. Evie will send a letter talking about the program
 1. Will discuss fees and opt-ins, etc
 2. Will discuss smarthinking and other resources. Will talk about free and commercial resources
 - iii. Advisors will send an email as well, finishing out the transition process and letting the student know that advisors are available and this is how you get in touch, etc.
 2. Student Affairs
 - a. CRC sending an email to this group to register for the virtual and live resource fair in late February
 - b. CRC will come do a presentation Feb 1st to talk to the PaCE meet-up students
 3. Links Orientation
 - a. Sent out reminders again today. 72% of admitted have registered, 62% of those 72% (40% of admitted students) have fully finished. Kris is going to look at deferring holds late next week.
 4. UF Online One Stop Center
 - a. Upper division transfers are done, some lower division and FTIC decision pending
 - b. Working to hire last coordinator
 - c. Working on phone interviews for recruitment center folks
 - d. Everyone except Melissa is now in the new space on the 3rd floor. Melissa will be moving up next week
 - e. UFO One Stop does not have lobby space for students seeking in-person assistance. If students are on-campus, should talk to Financial

Aid/Bursar/Registrar directly. If needed for Admissions, UF Admissions will call a member of the One Stop team down to assist.

- f. Readmission discussion – deadlines are confusing and somewhat problematic with the colleges. One Stop is not in the mix with the process, but will work to try and help get things streamlined
 - g. Go live with recruiting center is February 1st
 - i. ROC – Recruitment an Outreach Center
 - h. UFO Administration and Enrollment Management working on revamping the deadline calendar
 - i. Summer was pushed as late as possible due to lower enrollments in summer as well as the missing month of recruitment between Pearson and ROC transition
5. Curriculum Monitoring
- a. Concerns about classes filling up
 - b. IUF1000 - at least 60 for summer
 - c. Courses not in schedule but to note:
 - i. LIS2001 – Library research course (2F96)
 - ii. CLP4110 – Eating Disorders may be last chance to take this, as professor is retiring. PSY2012 pre-req
