



UF Online Advising Group Meeting
Thursday 3/23/2017, 2:00 PM

- 1) Approval of 3-9-17 minutes
 - a) Minutes are approved.
- 2) UFO Updates and News – (TJ)
 - a) UF Online will be holding meetings with the colleges.
 - i) Please look out for invitations next week.
 - ii) These meetings will be with the colleges, not specific departments.
 - iii) The primary focus of these meetings will be maintaining the relationships with academic departments regarding course development, advising, etc.
 - b) Evie is in discussions with enabler companies to help bring out of state students to UF Online.
 - i) These companies are associated with employers, to hopefully tie UF Online in with employer benefits.
 - c) A few PaCE students transitioned from UF Online to residential with less than a 2.0 UF GPA.
 - i) This should not be standard practice.
 - ii) If you transition a student with less than a 2.0 UF GPA, please make sure to thoroughly document your reasoning.
 - (1) One student in this case had 6 courses in a term (4 transient courses, 2 UF Online).
 - (2) Please keep this in mind as you are advising students regarding transient work.
 - iii) There is less concern with students transitioning with less than 60 hours (58-59 hours), but it should still be an exception, not a rule.
 - d) TJ has a UF Online student demographics Excel spreadsheet that he will send out to everyone.
 - i) If you have any requests for specific data, talk to TJ and Jeannie.
 - ii) OIPR also has similar reports in Tableau that you can utilize.
 - iii) TJ will include the opt-in fee package as part of the data.
 - iv) The PaCE students in the data are UF Online, non-transitioned PaCE students.
 - e) Immunization
 - i) There are ongoing discussions regarding whether or not PaCE and optional fee package students will be required to submit their immunization documentation.
 - ii) Please encourage your incoming PaCE students to submit this at Preview.
- 3) UFO Deadlines, Events, Reminders, and Announcements – (Glenn)
 - a) The first Florida Days event was held on March 13th.

- i) There were 4-5 visitors to the PaCE table.
 - ii) There were 14 PaCE students and families across the 3 breakout sessions.
- b) The PaCE chats are all completed.
- c) PaCE students were invited to the Destination Florida days as well, although UF Online is not participating in those events.
- d) The file completion deadline for Summer applications is March 31st.
- 4) Student Success Initiatives (Meredith)
 - a) UF Plaza
 - i) The plan is to have current students added by April, except students graduating in May.
 - ii) Let Jeannie or Meredith know if you have any questions.
 - iii) Advisors should already have access, but if you do not please let TJ or Jeannie know.
 - iv) The website is www.ufonline.ufl.edu/plaza .
 - v) Right now, it has not been decided whether transitioned PaCE students or UF Online alumni will be able to access the Plaza.
 - b) Meredith will be going to the UF Coral Gables office on Saturday, March 25th for an event.
 - i) If you are interested in which students in your college have RSVP'd to this event, let Meredith know.
 - ii) "Connections" will be the name for events like this that are networking related.
 - c) The Spring Graduation Reception will be on April 29th at 3:30-6PM.
 - i) An email invitation has been sent out to all students who applied to graduate.
 - (1) Students are welcome to bring guests as well.
 - (2) If you have students that did not receive the invitation, feel free to invite them!
 - ii) Faculty, staff, and advisors are encouraged to come.
 - (1) Please RSVP on the Eventbrite invitation if you'd like to come.
 - iii) It is a "drop-in" event, since the event overlaps multiple graduation ceremonies.
 - iv) Meredith will send out a report for each college to let them know how many of their graduates have RSVP'd.
- 5) PaCE (Meredith, Nicole)
 - a) TJ will add a report with the 2017 PaCE processed contracts, which will list the total count as well as the counts for each major.
- 6) Marketing/Communication (Kathy)
 - a) We are tracking ahead of last year in terms of how many leads are being generated.
 - b) Please continue to send updates to Kathy about the new UF Online websites.
- 7) Links Orientation (Kris)
 - a) Links enrollment is on track compared to last year.
 - b) Around 30 PaCE 2017 students have registered for Preview.
 - i) No comparable data since PaCE Preview registration did not open until May last year.
 - c) NSFP is hoping to avoid using the August 12th PaCE preview date, but they won't know for sure until June most likely.
 - d) If you have a student that cannot attend any of the Preview dates, or is out of state, refer them to Kris.

- 8) Enrollment Management: ROC & OneStop (Daniel)
 - a) OneStop
 - i) 124 PaCE 2017 contracts have been received and processed.
 - ii) Still working on finalizing Summer application files.
 - iii) With a few exceptions, all files have been sent to colleges who make transfer decisions.
 - iv) If you have any questions about the new UF Online admission application, please let Daniel know.
 - (1) It will be one application for all types of students (postbac, freshman, transfer, readmission)
 - (2) The goal is to have the new application go live in Fall.
- 9) Colleges/Departments (Judy)
 - a) CJC has added a section of Rock n' Roll in America (MMC 3702) for Summer C 2017.
