

**Deferral Process**

- Deferment of enrollment will only be granted if you do not take any additional coursework since your initial admissions decision. *If you take additional coursework after acceptance, you will need to reapply to UF Online.*
- Deferment of enrollment will only be granted up to one year from your initial acceptance. *If you do not start within that one year window, you will need to reapply to UF Online.*
- A signed copy of this form must be received by the UF Online OneStop no later than two weeks after the add/drop period ends for the term to which you were initially accepted. *If you miss the deferment deadline for your term, you will need to reapply to UF Online.*
- The Office of Admissions reserves the right to ask for additional information and the right to deny the request for deferral.
- You will be notified via email once a decision on your request for a deferral is made.
